EXECUTIVE ORDER NO. 04
Series of 2022

AN ORDER CONSTITUTING THE PROVINCIAL DEVELOPMENT COUNCIL OF ZAMBOANGA DEL NORTE, DEFINING ITS COMPOSITION AND FUNCTIONS.

WHEREAS, Section 106 of the Local Government Code of 1991, provides that each local government unit shall have a comprehensive multi-sectoral development plan to be initiated by its development council and approved by the Sanggunian Panlalawigan;

WHEREAS, the development council shall assist the Sanggunian in setting the direction of economic and social development, and coordinating development efforts within its territorial jurisdiction;

WHEREAS, Section 112 of RA 7160, states that the local development council may form sectoral or functional committees to assist the council in the performance of their functions;

WHEREAS, local government units are mandated to promote the establishment and operation of people's organization, and the private sector to make them active partners in the pursuit of local autonomy;

WHEREAS, Section 107 and 108 of RA 7160 provides for the composition of the Local Development Council including the representation of non-governmental organizations (NGOs);

NOW THEREFORE, I, ROSALINA G. JALOSJOS, Governor of the Province of Zamboanga del Norte, by virtue of the power vested in me by law, do hereby constitute the Provincial Development Council (PDC) of Zamboanga del Norte with the composition and functions hereunder specifically defined:

SECTION 1. Composition of the Provincial Development Council General Assembly. The Provincial Development Council General Assembly of Zamboanga del Norte shall be composed of the following:

Chairperson : **Provincial Governor**

Vice-Chairman : **Provincial Administrator**

Members : **All 27 City/Municipal Mayors**

Chairperson, Committee on Appropriation of Sangguniang Panlalawigan

Representatives of the three (3) Congressional Districts of Zamboanga del Norte

CSOs, POs & NGO's : **At Least Eight (8)**

SECTION 2. Functions of the Provincial Development Council (PDC) General Assembly. The PDC General Assembly shall have the following functions:

- a. Formulate long-term, medium-term, short-term and annual socio-economic development plans and policies;
- b. Formulate the medium-term and annual investment programs;
- c. Appraise and prioritize socio-economic development programs and projects;
- d. Formulate local investment incentives to promote the inflow and direction of private investment capital;
- e. Coordinate, monitor and evaluate the implementation of development programs and projects; and
- f. Perform such other functions as may be provided by law or competent authority.

SECTION 3. Meetings and Quorum of PDC General Assembly. The PDC General Assembly shall meet at least once every six (6) months or as often as may be necessary and simple majority of the members shall constitute a quorum.

SECTION 4. Composition of Provincial Development Council Executive Committee. The PDC Executive Committee shall be composed of the following:


SECTION 5. Functions of the PDC Executive Committee. The functions of the PDC Executive Committee shall be as follows:

- a. Ensure that the decision of the council are faithfully carried out and implemented;
- b. Act on matters requiring immediate attention or action by the council;
- c. Formulate policies, plans and programs based on the general principles laid down by the council; and
- d. Act on other matters that may be authorized by the council.

SECTION 6. Meetings and Quorum of PDC Executive Committee. The PDC Executive Committee shall meet as often as may be necessary or as being called by the Provincial Governor and simple majority of the members shall constitute a quorum.

SECTION 7. Effectivity. This Order shall take effect immediately and shall be in full force and effect until otherwise amended, revised, revoked or rescinded.
