EXECUTIVE ORDER NO. 05

“AN ORDER ORGANIZING THE PROVINCIAL HEALTH BOARD OF ZAMBOANGA DEL NORTE, DEFINING ITS COMPOSITION AND FUNCTIONS.”

WHEREAS, the Local Health Board functions in the local government units are not only vital but indispensable in its normal operation;

WHEREAS, Section 102 of RA 7160 otherwise known as the Local Government Code of 1991 provides the establishment of Local Health Board in every province, city and municipality;

WHEREAS, the basic and fundamental functions built-in in the Local Health Board mandated the establishment of the same in the provincial government.

NOW, THEREFORE, I ROSALINA G. JALOSJOS, Governor of the Province of Zamboanga del Norte, by virtue of the powers vested in me by law, do hereby organize the Provincial Health Board of Zamboanga del Norte with the composition and functions hereunder specifically defined:

SECTION 1. Composition. The Provincial Health Board of Zamboanga del Norte should be composed of the following:

Chairperson	:	Provincial Governor
Co-Chairperson	:	Provincial Administrator
Vice-Chairman	:	Provincial Health Officer
Members	:	Chairperson, Committee on Health of the Sangguniang Panlalawigan
		Representative of the Department of Health, Provincial Office
		Private Sector Representative
		NGO Representative
		Representative of BHW
		Head of Provincial Planning and Development Office
		Head of the Provincial Budget Office
Secretariat	:	Provincial Health Office


SECTION 2. Functions of the Provincial Health Board. In pursuance of its goals and objectives, the Local Health Board shall:

1. To propose to the Sangguniang Panlalawigan, in accordance with the standards and criteria set by DOH, annual budgetary allocations for the operation and maintenance of health facilities and services within the Province of Zamboanga del Norte;
2. To serve as an advisory committee to the Sannggunian Panlalawigan on health matters such as, but not limited to, the necessity for, and application of local appropriations for public health purposes; and
3. Consistent with the technical and administrative standards of the Department of Health, create committees which shall advise local health agencies on matter such as, but not limited to, personnel selection and promotion, bids and awards, grievance and complaints, personnel discipline, budget review, operations review and similar functions.

SECTION 3. Meeting and Quorum. The Provincial Health Board shall meet at least once a month or as often as may be necessary. A simple majority of its members shall constitute a quorum, but the chairman or the vice-chairman must be present during meetings where budgetary proposals are being prepared or considered. The affirmative vote of all the majority of the members shall be necessary to approve such proposals.

SECTION 4. Effectivity. This Order shall take effect immediately and shall be in full force and effect unless otherwise amended, revised, revoked or rescinded.
