INVITATION TO BID

Rehabilitation of Roxas-Denoman-Capase Provincial Road (Denoman Section) Brgy. Denoman, Roxas, Zamboanga del Norte

The Provincial Government of Zamboanga del Norte through the General Fund of 2026 intends to apply the sum of **Six Million Two Hundred Seventeen Thousand Five Hundred Thirty Seven Pesos & 38/100 only (Php 6,217,537.38)** being the approved Budget for the Contract (ABC). Bids received in excess of the ABC shall be automatically rejected at Bid opening.

The Provincial Government of Zamboanga del Norte now invites sealed Bids from eligible Bidders and PhilG-EPS Registered (Philippine Government Electronic Procurement System) for the Rehabilitation of Roxas-Denoman-Capase Provincial Road (Denoman Section) Brgy. Denoman, Roxas, Zamboanga del Norte under **PR # 300(18)26-02-003(O)**. Completion of Works is required for **Forty Four (44) Calendar Days**. Bidders should have completed a contract similar to the Project. The description of an eligible Bidder is contained in the Bidding Documents, particularly, in Section II. Instruction to Bidders.

Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criteria as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act No. 9184 (R.A. 9184), otherwise known as the "Government Procurement Reform Act".

Interested bidders may obtain further information from the BAC Office, Capitol Building, Barangay Estaka, Dipolog City and inspect the Bidding Documents at the address given below from 8:00am to 5:00pm.

A complete set of Bidding Documents may be acquired by interested Bidders on **February 13, 2026 to March 10, 2026** from the address below and upon payment of a nonrefundable fee for the Bidding Documents in the amount of **Ten Thousand Pesos Only (Php 10,000.00)**.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the Provincial website (<http://www.zamboangadelnorte.gov.ph/>) provided that bidders shall pay the non-refundable fee for the Bidding Documents not later than the submission of their bids.

The Provincial Government will hold a Pre – Bid Conference on **February 24, 2026 at 10:00 o'clock in the morning** at the BAC Conference, Capitol Building, Barangay Estaka, Dipolog City, which shall be open only to all interested parties who have purchased the Bidding Documents.

Bids must be delivered to the address below on or before **March 10, 2026 at 10:00 o'clock in the morning**, late bids shall not be accepted. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in the ITB Clause 16.

Bid opening shall be on **March 10, 2026 at 10:00 o'clock in the morning** at BAC Conference, Capitol Building, Barangay Estaka, Dipolog City, unless announced otherwise. Bids will be opened in the presence of the Bidders' representative who choose to attend the activity.

The Provincial Government of Zamboanga del Norte reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised Implementing Rules and Regulations (IRR) of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
