**INVITATION TO BID**

**Construction of ZN-PAIC Consolidation Center for Mango Growers at Barangay Upper Irasan, Municipality of M.Roxas**

The Provincial Government of Zamboanga del Norte through the General Fund of 2026 intends to apply the sum of **Three Million Four Hundred Forty Six Thousand Two Hundred Thirty Eight Pesos & 92/100 only (Php 3,446,238.92)** being the approved Budget for the Contract (ABC). Bids received in excess of the ABC shall be automatically rejected at Bid opening.

The Provincial Government of Zamboanga del Norte now invites sealed Bids from eligible Bidders and PhilG-EPS Registered (Philippine Government Electronic Procurement System) for the Construction of ZN-PAIC Consolidation Center for Mango Growers at Barangay Upper Irasan, Municipality of M.Roxas under **PR # TF-26-01-001(O)**. Completion of Works is required for **Eighty Eight (88) Calendar Days**. Bidders should have completed a contract similar to the Project. The description of an eligible Bidder is contained in the Bidding Documents, particularly, in Section II. Instruction to Bidders.

Bidding will be conducted through competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the IRR, otherwise known as the “New Government Procurement Act (NGPA)”.

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines.

A complete set of Bidding Documents may be acquired by interested Bidders on **March 19, 2026 to April 09, 2026** from the address below and upon payment of a nonrefundable fee for the Bidding Documents in the amount of **Five Thousand Pesos Only (Php 5,000.00)**.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the Provincial website (<http://www.zamboangadelnorte.gov.ph/>) provided that bidders shall pay the non-refundable fee for the Bidding Documents not later than the submission of their bids.

The Provincial Government will hold a Pre – Bid Conference on **March 26, 2026 at 10:00 o'clock in the morning** at the BAC Conference Room, Capitol Building, Barangay Estaka, Dipolog City, which shall be open to prospective bidders.

Bids must be duly received by the Bids and Awards Committee (BAC) Secretariat through manual submission at the address indicated below on or before **April 09, 2026 at 10:00 o'clock in the morning**. Late bids shall not be accepted.

All Bids must be accompanied by a Bid Security in any of the acceptable forms and in the amount stated in **ITB** Clause 16.

Bid opening shall be on **April 09, 2026 at 10:00 o'clock in the morning** at BAC Conference, Capitol Building, Barangay Estaka, Dipolog City, unless announced otherwise. Bids will be opened in the presence of the Bidders' representative who choose to attend the activity.

The Provincial Government of Zamboanga del Norte reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 70 of R.A. No. 12009, without thereby incurring any liability to the affected bidder or bidders.
